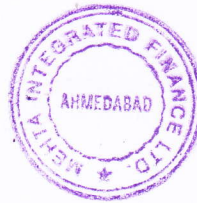

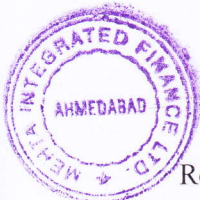

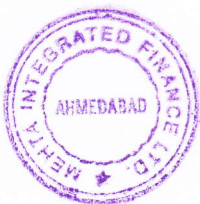

ORDER BELOW EXHIBIT-68

1. The present application is moved by the award holder under Order 21 Rule 46 of the Code of Civil Procedure 1908 (in short, 'the Code') against the garnishes as mentioned in the present application and thereby, it is requested not to transfer the shares and also from taking the dividend of these shares and not to create any charge over on the shares lying with the garnishes.
2. Heard the Learned Advocate Mr. M.K. Mansuri for the award holder at length.
3. On going through the present application supported by affidavit of the award holder concerned and along with the documents, it seems that the award debtor Nos 2, 3 & 4 are having certain interest in the form of shares in the various

companies and that is why, the present application is moved under Order 21 Rule 46(1)(b) of the Code.

4. This Court can not lost its sight towards the fact that Section 34 of the Arbitration & Conciliation Act, 1996 has already been dismissed and even before the Hon'ble High Court of Gujarat, no any stay has been yet granted since many adjournments have been taken place before the Hon'ble High Court of Gujarat.
5. As per documents attached with the list, there are four statement showing share holding pattern of the promoter and promoter group as on dated 31.12.2025, 31.03.2025, 31.03.2024 & 31.03.2024 respectively.
6. Therefore, in such peculiar facts and circumstances, whatever the shares are being held by the present judgment debtors with the garnishes, must be attached, so that there would be no any further chance of transfer or alienating the shares if any, lying with the garnishees. **Hence, the garnishes as mentioned in the present application, are hereby directed to freeze [to be kept as it is] the shares of the Judgment Debtor lying with them & dividend accrued thereon with immediate effect. Hence the present order be served along with a copy of the present application upon the garnishes as mentioned in the present application, forthwith.**

7. A notice to the Garnishes with present status *qua* the shares of the Judgment Debtor be served, ***returnable on 08.04.2026.***

8. Direct Service is permitted.
