Kindly take this revised documents on record and cancel the ref. no. 4603291 document upload at BSE Portal and Oblige.

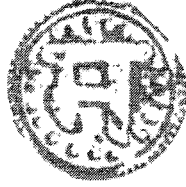

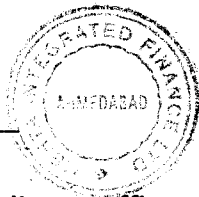

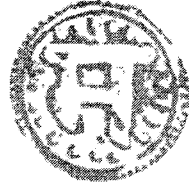
